- Pastor Chris discussed recent staff changes. Molly Schunicht resigned as director of the Windsor Bells and Youth Music Ensembles. Amanda Lauritsen is on a term contract as director of the Youth Music Ensembles. She is an elementary music teacher in the Waukee school district. Marilyn Harvey, former and retired bells director, has signed a term contract to direct the Windsor Bells. Re-evaluation will occur for Fall 2017 plans. Caitlyn Reinders resigned this last month as Youth Ministry Coordinator. Reinders has taken a full-time youth & congregational life

position in Illinois. In addition, Tania Schramm will be leaving her post as Children's Ministry Coordinator in May for her internship as part of the seminary program. The needs for youth and family ministries were discussed, including a possible candidate that may be available as an interim leader or the use of volunteers. It was agreed that contact be made with a potential candidate to gather interest.

 Pastor Chris shared his responsibilities with a community taskforce to understand bigotry and racial issues in the community and how the faith community could participate and respond.
